#### SAVE THE TREES



"Please say yes!" Local children present our petition

Twenty iconic trees in the historic sunken lane are now protected by law. Mole Valley District Councillors voted unanimously to set up a Tree Preservation Order in response to a petition from A Voice for Leith Hill.

Tree Preservation Orders protect amenity trees at risk. "We're delighted that the Council has made this order, after a long campaign and raising over 2000 signatures," said Sarajane Ferris, of A Voice for Leith Hill.

"These veteran trees on this historic lane can't speak for themselves so the community has given them a voice. They face damage and disturbance from the hundreds of heavy lorry movements that the oil drilling threatens".

The group raised funds to commission a tree report by Furlonger Tree Services, an independent aboriculturalist, which said that healthy beech and oak trees "were at risk from damage and any loss would harm the character and appearance of the historic environment in the lane."

Maximum penalties for breaching a Tree Preservation Order are an unlimited fine from the Crown Court and a £20,000 fine from the Magistrates' Court.

The Leith Hill Protection Camp was set up in 2016 as a front line of defence for the hill, and originally occupied the intended drill site off Coldharbour Lane. It took two days in June to evict us, after a dawn raid by specialist climbing and tunnelling bailiffs. Although the iconic 'Cathedral in the Woods' was destroyed we simply moved across the road.

The camp is currently raising awareness of what's happening and keeping an eye on Europa's activities. We love visitors and everyone is welcome for tea and a chat round the fire. From Dorking you'll find us on the left hand side, around half a mile back from Coldharbour village. We're planning a special Equinox Warmer event at 6pm on Friday 22nd September. ### HISTORY OF THE FIGHT AGAINST OIL

Back in 2008 Europa Gas & Oil applied to carry out an exploratory drill in Bury Hill Woods in the Surrey Hills Area of Outstanding Natural Beauty and Green Belt. Coldharbour and Dorking residents were astounded. Local parish and district councils, the National Trust, the local water authority and thousands of individuals objected to the proposal. Despite this and the tireless work of local lobby group Leith Hill Action Group, permission was eventually granted by the Govt. Planning Inspectorate in 2014.

A Voice for Leith Hill started with a picnic on the proposed wellsite in 2015. It's a non-political community group which felt that this beautiful woodland area needed a voice and decided to raise awareness locally and nationally through a series of events.

Following approval in 2014, Europa have had to submit detailed plans for development and every word and drawing has been scrutinised by LHAG, A Voice for Leith Hill and other groups. Inconsistencies and inaccuracies have been exposed and this fight has continued for 3 years.

#### AND NOW?

Europa still need to gain planning approvals relating to traffic management and fencing, as well as Environment Agency permits. If they are granted, then unbelievably we could soon see the first huge lorries attempt to drive up our historic sunken lane to the site.

#### Weald Wide Watch

Oil companies are expected to make over **900** applications to drill the Weald in Surrey, Sussex, Kent and Hampshire. Stephen Sanderson of UKOG said ''This type of oil deposit ... depends on drilling your wells almost back to back so it becomes ... an industrialised process". So, Europa's explorations at Leith Hill might be part of a much larger plan. The view from Coldharbour could one day be very different... instead of bonfire smoke, we'd see gas flares belching from drill sites.

**Brockham:** Angus Energy drilled a sidetrack without permission from Surrey County Council. SCC's lawyers have upheld the planners' view. Angus's application for retrospective planning permission for the installation of other site facilities is being heard at the SCC offices, Kingston, on Wednesday Sept13<sup>th</sup>.

**Billingshurst (Broadford Bridge):** UKOG have drilled this summer and are seeking a one year extension. The local community holds regular 'cake at the gate' blockades. See them on Facebook.

Horse Hill (Gatwick): A consortium including UKOG explored for oil. A temporary Protection Camp was set up and 'slow walk' protests took place. Residents complained of headaches, nosebleeds & water pollution. The consortium has now applied for an extension.

Markwells Wood (Portsmouth): UKOG have for now withdrawn their application to drill and acidise after Markwells Wood Watch crowdfunded an independent hydrogeological report.

**Balcombe.** Cuadrilla drillled a well in 2013. After huge protests they went quiet for years, but have just applied to the Environment Agency for new permits.

Lidsey, nr Bognor: Angus Energy have just brought a drilling rig onto the site (see pic) and can go into immediate production. Europa no doubt hope to use this rig at Leith Hill.
