## INDEPENDENT REPORTS HIGHLIGHT DRILLING RISKS

A Voice for Leith Hill and a local campaigner recently submitted two major new geological and hydro-geological reports to the Environment Agency (EA). They reveal significant and disturbing information:

1. Europa seem to have misunderstood the geology of the area, including the position of geological faults
2. The shallow intended path of the borehole is at the limits of current technology and therefore the risk of well integrity (breakdown) issues is increased
3. The deposits being targeted in the South East are unconventional by any scientific definition, and would require stimulation (acidisation & acid fracking) to extract them commercially
4. The suggested monitoring plan would not be enough to tell if unlicensed fracking was taking place.

This is just a selection of the serious issues raised. Expert geologist Professor David Smythe provided the second report. Dorking residents and campaigners packed the Friends' Meeting House to hear him speak on his findings and the dangers of oil exploitation in the Weald. ## HIGH COURT CHALLENGE TO UKOG INJUNCTION



Human rights campaigner Bianca Jagger joined Weald-wide objectors to United Kingdom Oil & Gas's draconian injunction outside the High Court on March 19th. Members of threatened communities (Leith Hill, Broadford Bridge & Horse Hill among others) packed the hearing room. The judge decided to hold a three-day hearing in June.

Since then UKOG have removed their most contentious clauses restricting lawful action which might damage their commercial interests but the fight goes on. The Weald Action Group have launched a Crowdfunding appeal to cover the legal costs of this battle. ## BROCKHAM: 'PRIVATE EYE' SPEAKS OUT

As Angus Energy applies for retrospective planning permission for its sidetrack drilled in January 2017, 'Old Sparky' of 'Private Eye' has something to say. He reveals that in 2014 Angus Energy commissioned a report from Prospect Ltd, a specialist consulting agency. In it they write that Angus should 'require a new planning application for any works'. Surrey County Council advised them of this twice in writing but AE went ahead anyway.

## STORY OF THE FIGHT VS OIL

Back in 2008 (TEN YEARS AGO!) Europa Oil & Gas applied to carry out an exploratory drill at Bury Hill Woods on Leith Hill. Local parish and district councils, the National Trust, the local water authority and thousands of individuals objected to the proposal. Despite this and the tireless work of local lobby group **Leith Hill Action Group**, permission was granted by the Govt Planning Inspectorate in 2014.

**A Voice for Leith Hill** started with a picnic on the proposed well-site in 2015. It's a community group that wants to give a voice to this beautiful woodland area.

Since 2014 every word and drawing of Europa's plans has been scrutinised by LHAG, A Voice for Leith Hill and other groups. Inconsistencies and inaccuracies have been exposed. The fight goes on; more and more people are finding their voice!

**Billingshurst (Broadford Bridge):** UKOG have stopped work at the site and announced plans for 2 more sites nearby.

**Horse Hill (Horley):** UKOG are preparing for more flow testing.  
**Markwells Wood (South Downs):** UKOG withdrew a previous application; South Down National Park has told them to restore the wellsite to its original state but they tell shareholders a different story.

**Balcombe (Sussex):** Angus Energy have bought the production licence to drill for oil.

**Lidsey (nr Bognor):** AE are producing c80 barrels a day.
